Part of Italy's foreign policy, the Italian Development Cooperation highlights two priorities: 1) Ensure the protection of all the planet's inhabitants lives, as well as their human dignity. 2) To cooperate as a method to install, improve and strengthen relations between different countries and communities. Italy highly promotes Human Rights as a fundamental base for its foreign policy and it is constantly reminding other countries to make sure that they are acting in order their obligations in this theme.

Just to mention an example of Italy's intervention in other countries, for the resolution of internal political problems in other countries. Italy's defense minister, Roberta Pinotti made an statement in 2015 of "sending troops into Libya" to assist the government to regain control over this particular country. Italy's main goal is to stabilize Libya, where the legitimate government has almost lost all of its power due to Libya's political conflict. Italy by helping the Libyan legitimate government, wants to reduce the flow of refugees that are arriving to the Italian territory and help Libya to find its peace, by finding an appropriate resolution to its internal conflict.

As a defender of the Human rights and as a member of the United Nations, Italy is using diplomatic pressure to make any state responsible of violations to the Human Rights to solve its humanitarian crisis, and if the country is not doing something to improve their current situation, Italy is ready to intervene in the situation that country to help improve the conflict. Italy has been involved in many scenarios before, where people's Human Rights are being violated and it has taken actions to help those countries to find better resolutions of its internal conflicts. Italy has participated in many treaties for international peace and it believes that the intervention of external forces in other countries to help to resolve internal conflicts should be implemented if needed.

To sum up the posture of the delegation of Italy about the International Intervention in Political Violence and Affairs on this Matter, the next three statements will be presented:

1.-Italy believes that external forces in other countries should be implemented if needed.

2.-Italy wants countries with Human Rights crisis to work in solving their problems to prevent a major problem.

3.-Italy is ready to help countries with internal conflicts, not just military but with financial aid and with the distribution of products for human's basic necessity.
